

Dear Parent/Guardian:

We have recently been notified that a student or an employee at your child's school has recently tested positive for the virus that causes COVID-19. This virus is transmitted through respiratory droplets produced when an infected person coughs, sneezes or talks. Persons within six feet for more than 15 minutes are considered *Close Contacts* and are at increased risk of developing this infection. A person who is a *Close Contact* with someone during their potential infectious period is required to self-quarantine for at least 14-days after the most recent contact.

You are receiving this letter because your child has shared a classroom or other gathering space with the tested individual and meets the criteria of a *Close Contact*. Your child is **required** to self-quarantine. The Rock County Public Health Department or the Wisconsin State Contact Tracing Team will be contacting you within the next few days to complete a full investigation and provide you with further quarantine guidance. Your child should avoid contact with people outside of your household while in quarantine.

Although we must protect the privacy of the person involved, the health and safety of our staff and students is a top priority. We are providing you with the following information so you are aware of how long you will need to monitor for symptoms. Please monitor for symptoms of illness in your child for 14 days from the date of last exposure. The dates below are subject to change based on the investigation.

If your child exhibits any symptoms of COVID-19, we ask that you immediately seek the advice of your medical provider. Some symptoms of COVID-19 may include fever, new cough, shortness of breath, sore throat, headache, fatigue, muscle aches, or loss of taste or smell. Symptoms typically start to appear 2-14 days after exposure to the virus.
